**Inclusion**

Inclusion for special needs populations will be a standard for all Rio Rancho Parks, Recreation and Community Services programs. If special accommodations are required, please inform staff upon registration.

**Refund Policy**

Refunds are granted if the request is prior to the registration deadline and the withdrawal is not detrimental to the program. There will be a \$5 administrative fee.

If a refund is requested after the registration deadline and it is determined that the refund will be detrimental to the program (i.e. group rates based upon registration numbers) then no refund may be given.

If refunds are requested prior to the service starting and there are participants willing to take the space of the person requesting the refund, then a refund may be processed with a \$5 administrative fee. If a refund request is made after the start of the service, a pro-rated fee may be refunded and the new person filling the vacancy may pay a pro-rated registration fee.
